1. Overview

This agreement describes the terms and conditions for participation in The Blockchain Store affiliate program. In this agreement, the term "Affiliate" refers to you (the applicant). In this agreement, The Blockchain Store and "we" refers to the product owner and publisher, The Blockchain Store.

2. Enrollment

To enroll in the affiliate program, you must read this agreement in its entirety, sign the bottom page, supply the PayPal account email address intended to receive affiliate payments, supply The Blockchain Store with the promotional code(s) names you wish to use, and send the signed form, promotional code(s), and PayPal account information via email to info@blockchainstore.xyz. Acceptance status will be confirmed via email as soon as possible after the information is reviewed.

3. Commissions

Affiliates will receive 10% of the revenue of products sold as a commission from orders placed using the Affiliate's personal promotional code(s). For a sale to generate a commission to an Affiliate, the customer must complete an order, use the Affiliate's promotional code(s), and remit full payment for the product(s) ordered through The Blockchain Store's online store. Word of mouth referrals will not result in an affiliate commission being generated. Commissions will only be paid on sales that are made when the customer enters the Affiliate's promotional code(s).

4. Payment

The Blockchain Store pays affiliates via a PayPal account, provided to us when a member joins. If the PayPal email changes, it is the responsibility of the affiliate to notify The Blockchain Store to ensure proper commission payments.



5. Order Fulfillment

The Blockchain Store will be solely responsible for processing every order placed by a customer. Affiliates are not authorized to collect payments or sell any of The Blockchain Store's products from other websites as a "reseller" and no "resale" rights are granted in any way. Affiliates are not authorized to sell any of these products on ebay or other auction sites. Affiliates are not authorized to give away copies of any of these products. The Blockchain Store will also be solely responsible for all customer service inquiries.

Customers who purchase products and services through The Blockchain Store's Affiliate Program will be deemed to be customers of The Blockchain Store. Accordingly, all rules, policies, and operating procedures concerning customer orders and service will apply to those customers. We may change our policies and operating procedures at any time. Prices and availability of our products and services may vary from time to time. The Blockchain Store policies will always determine the price paid by the customer.

6. Permitted Usage

Affiliates are permitted to use The Blockchain Store's logo and designs located on The Blockchain Store's website (www.blockchainstore.xyz) for promotional purposes. If the Affiliate is seeking a specific design, banner, or logo for promotional purposes, he or she can contact The Blockchain Store to request it. The Blockchain Store is not responsible for helping the Affiliate create marketing and promotional materials other than supplying requested graphics and information at The Blockchain Store's discretion.

7. Prohibited Usage

The following cases are prohibited and are grounds for immediate termination of the affiliate account.

- Affiliates MAY NOT promote coupons that were not provided to them personally by The Blockchain Store. Want to promote a coupon? Contact us and we can work with you. You may NOT promote coupon codes you may have found elsewhere online. Doing so can result in the termination of your affiliate account and withholding of affiliate payments for violating our affiliate agreement.
- Affiliates MAY NOT host or promote "coupon stacking" sites where customers may combine coupons to receive additional discounts.

8. The Blockchain Store Anti-Spam Policy

The Blockchain Store strictly prohibits affiliates from using spam e-mail and other forms of Internet abuse (including spamming forums, blogs, twitter, facebook and other social media outlets) to seek sales. Spam is defined as including, but not limited to, the following:

- Electronic mail messages addressed to a recipient with whom the sender does not have an existing business or personal relationship or is not sent at the request of, or with the express consent of, the recipient through an opt in subscription;

- Messages posted to forums, Twitter, Facebook and message boards that are off-topic (unrelated to the topic of discussion), cross-posted to unrelated newsgroups, posted in excessive volume, or posted against forum/message board rules. Be conscious of forum rules! If a forum owner or moderator complains that an affiliate has spammed, the affiliate account may be permanently terminated after investigation;
- Content posted on free blog websites for the sole purpose of keyword spamming, or comments posted to legitimate blogs that violate the comment policy of the blog owner;
- Solicitations posted to chat rooms, or to groups or individuals via Internet Relay Chat or "Instant Messaging" system.

The Blockchain Store, may undertake, at its sole discretion and with or without prior notice, account termination. Upon the receipt of a credible complaint, The Blockchain Store Affiliate Program manager may investigate the complaint, and if necessary, will then terminate the affiliate account of the individual implicated in the abuse. Termination results in the immediate closure of the member and affiliate account, the loss of all referrals, and the forfeiture of any unpaid money on account.

9. Relationship of Parties

Affiliates are independent contractors, and nothing in this Agreement will create any partnership, joint venture, agency, franchise, sales representative, or employment relationship between the parties. Affiliates have no authority to make or accept any offers or representations on our behalf. Affiliates will not make any statement, whether on their sites or otherwise, that reasonably would contradict this statement.

10. Modification

We may modify any of the terms and conditions within this Agreement at any time and at our sole discretion. These modifications may include, but are not limited to changes in the scope of available referral fees, fee schedules, payment procedures and Affiliate Program rules. If any of the modifications are UNACCEPTABLE TO YOU, your only recourse is to terminate this Agreement. If you CONTINUE PARTICIPATION IN THE PROGRAM, it will be considered as your acceptance of the change.

11. Term and Termination

The term of this Agreement will begin when you accept and will end when terminated by either party. Either The Blockchain Store or the affiliate may terminate this Agreement at any time, with or without cause.

12. Limitation of Liability

The Blockchain Store will not be liable for indirect, special, or consequential damages (or any loss of revenue, profits, expenditures or data) arising in connection with this Agreement or the Program, even if we have been advised of the possibility of such damages. Further,



our aggregate liability arising with respect to this Agreement and the Program will not exceed the total commissions paid or payable to the affiliate under this Agreement.

13. Disclaimers

We make no express or implied warranties or representations with respect to the Affiliate Program or an affiliate's potential to earn income from the Affiliate Program. In addition, we make no representation that the operation of the websites or the Affiliate promotional code(s) will be uninterrupted or error-free, and The Blockchain Store will not be liable for the consequences of any interruptions or errors.

14. Miscellaneous

If any of the provisions of this Agreement are determined by a court to be unenforceable, they shall be severed from this Agreement, and the remaining provisions shall remain in full force and effect.

By signing up with The Blockchain Store Affiliate Program, you acknowledge that you have read this agreement and agree to all its terms and conditions. You have independently evaluated this program and are not relying on any representation, guarantee or statement other than as set forth in this agreement.
